PROJECT INFORMATION

The client has asked Novocus Legal LLP to prepare evidence of use claim charts for a Horstmann patent bearing patent number - 5,995,099

The invention relates generally to a method that establishes page links between pages on the Internet. Individual sites (collections of pages) include dedicated links pages that consolidate links to other sites. The links page associated with a given site (the first site) includes an "add link" button that, when selected, allows an owner of a second site to add a link to the links page. The new link can be used to establish a link from the links page to the second site. To ensure reciprocity, the method also includes prompting the owner of the second site for a link back to a page of the first site and later checking the second site for the link back.

CLIENT INPUT

Client believes that WordPress makes use of similar linking methods. The client believes that WordPress is infringing upon patent US5995099 issued to Horstmann.

PROJECT PROCEDURE

The patent in question has been studied in detail along with product in question (WordPress). Technical features of the product have then been mapped over the claims of US Patent 5995099.

A tabular representation along with colour coding of correspondingly relevant sections from patent claims and product features has been chosen. This format would aid in visual comprehension of the claim to product overlap.

INVENTION SUMMARY

This invention comprises following key components:

- 1. A first site
- 2. A second site
- 3. A first entity
- 4. A second entity

These components can perform following functions:



- 1. The invention relates to a method of establishing a bidirectional link between the first site and the second site.
- 2. The first site can be controlled by the first entity that maintains authority over the first site and that lacks authority over the second site.
- 3. The method may include outputting a page A of the first-site to the second entity that maintains authority over the second site and that lacks authority over the first site.
- 4. The page A prompts the second entity to output first link information to initiate the bidirectional link between the first and second sites.
- 5. The method may include receiving the first link information from the second entity.
- 6. The method may include soliciting second link information from the second entity.
- 7. The second link information can be indicative of a page B of the second site that may or may not include a third link information depending upon verification of page B.
- 8. The third link information is only available after verification.

POINTS OF MAPPING

The product to be mapped in this case is WordPress Tool primarily. The technical feature to be mapped is reciprocal page linking wherein, the establishing reciprocal links is automated and involves user controlled verification.

For the purpose of establishing infringement and technical overlaps, we may consider any and all tools that can be used on a WordPress based website and have been allowed by WordPress platform.

The above mentioned point of infringement is illustrated in following patent claim to product technical features maps.

MAPPED PRODUCT AND MAPPING FEATURES

The invention has been mapped onto a plugin supported and hosted by WordPress called Wp-Trafficfeed (referred to as product). This plugin can be installed directly onto a WordPress based website. WordPress also has hosted this product as a relevant and valid plugin for link exchange over its website. It can be found on (https://wordpress.org/plugins/link-exchange-true-automatic-link-exchange-trafficfeed/)



The product automates the process of reciprocal link exchange. A summary of product operating procedure is mentioned below:

The product allows user of a WordPress website to automate process of link exchange. The product would allow user to select categories of type of links that user would be interested in. The product would then search and present user with various links pertaining to selected categories. User can select links that he/she wants to exchange link with.

The product would contact other users or webmasters of links or websites selected by the user. The product would present a link from the first user's website to users or webmasters of selected links. These users or webmasters may solicit the link from the first user shared by the product. These webmasters or users may approve or disapprove link exchange as per their wish.

Once the users/webmasters of selected links approve the first link, they would need to provide a link from their website to share with the first user. Also, they would specify a location on their website where they would place the first user's link.

This terminates the process of link exchange.

The product would then after sometime, verify and validate if users/webmasters of selected links are maintaining the link exchanged on a relevant page. The page relevance would be determined using specific keywords that first user has specified while making selections.

If relevant links are found missing or at improper places on selected users/webmasters websites then first user would get an intimation to take action. The product provides a separate section for link monitoring purposes.

The product also provides flexibility to the user to perform this process manually or automatically.

Due to all the above features and product working, we feel that this product is infringing upon US Patent 5995099. Also, WordPress may not be directly involved in process of link exchange in a manner similar to US Patent 5995099, but it supports and hosts a product that does.

from the second entity. The user would select keywords based on which first link information would be outputted. Also, the product requires the second entity to select a link for initiating bi-directional link from a variety of links available on the first site. (Refer Pictures 11-13).

soliciting second link information from the second entity, the second link information indicative of a page B of the second site that will include third link information but that does not include the third link information; and The product would require the user (second entity in this case) to provide a space on second website at a place where all exchanged links would be placed. Also, the user would be required to select page links from his website for placing the same on target website. These links would be the ones that he wishes to be placed upon the target site. The product also provides a check mark option for selecting links/pages. (Refer Figures 11-14 and Figures 21, 22, 25, 26).

The product would verify if user has provided space for links and also that exchange partners have approved the same and have been providing space for links at relevant places. Refer Pictures 35-38.





PICTURE 2: WORDPRESS PLATFORM PROVIDES AN OPTION OF ADDING SUPPORTED PLUG-INS




PICTURE 3: PRODUCT CAN BE SEARCHED USING WORDPRESS PLATFORM








PICTURE 4: PRODUCT GOES BY NAME OF WP-TRAFFICFEED IN WORDPRESS PLUG-IN LIST


PICTURE 5: PRODUCT CAN BE INSTALLED AS A WORDPRESS PLUG-IN




PICTURE 7: PRODUCT WOULD PROVIDE OPTION TO MAKE AN ACCOUNT ONTO PLATFORM


PICTURE 8: PRODUCT REQUIRES USER DETAILS




PICTURE 9: PRODUCT REQUIRES USER WEBSITE DETAILS AND DESCRIPTION




PICTURE 13: PRODUCT WILL ADD SELECTED PAGES


PICTURE 14: WORDPRESS INTERFACE WITH PRODUCT PRESENT AS A WIDGET




PICTURE 15: WORDPRESS INTERFACE WITH PRODUCT PRESENT AS WEBSITE LAYOUT WIDGET






PICTURE 17: WORDPRESS INTERFACE WITH PRODUCT PLACED AS PER USER SATISFACTION







PICTURE 20: USER HAS COMLETE CONTROL OVER WHERE TO PLACE LINKS AFTER EXCHANGE






PICTURE 22: PRODUCT PROVIDES VARIOUS OPTIONS FOR AUTOMATED LINK EXCHANGE












PICTURE 27: PRODUCT ENABLES DEFINING CATEGORY OF A WEBSITE FOR LINK EXCHANGE




PICTURE 31: PRODUCT AUTOMATICALLY CONTACTS USERS OF WEBSITES FOR LINK EXCHANGE








PICTURE 32: PRODUCT PROVIDES SEPARATE PLATFORM FOR LINK SUBMISSION MONITORING




PICTURE 34: PRODUCT PROVIDES A SPECIFIC TAB FOR LINK MANAGEMENT AND MONITORING








PICTURE 35: LINK EXCHANGE MANAGEMENT BY DATE
